

**CENTURY AUTOMOTIVE SERVICE CORPORATION**  
**EXTENDED SERVICE AGREEMENTS**  
**REINSURANCE WAREHOUSE STATEMENT**

CENTURY AUTOMOTIVE SERVICE CORPORATION, a corporation organized under the laws of the State of California, (hereinafter called "COMPANY") hereby agrees to cede all extended service agreements written through \_\_\_\_\_, (hereinafter called "PRODUCER") on or after the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, (hereinafter called "EFFECTIVE DATE") to a reinsurance company capitalized under the laws of the Turks and Caicos Islands, BWI or the Delaware Tribe of Indians, designated by PRODUCER, (hereinafter called "REINSURER") and formed and managed by COMPANY or one of it's affiliates.

The extended service agreement premiums ceded in consideration of such reinsurance shall be reduced by all ceding commissions, taxes, advance commissions, incurred claims, reinsurance fees and assessments, and any and all other expenses paid or allowed on the said premiums and will be ceded in accordance with the terms of Exhibit A attached and incorporated herein. Provisions of the Reinsurance Agreement(s) subsequently entered into between COMPANY and REINSURER will replace each party's obligation under this Agreement.

This Agreement shall terminate 9 months following the EFFECTIVE DATE of this agreement. This Agreement shall NOT be renewed or extended without the written approval of a designated officer of the COMPANY.

If PRODUCER fails to designate REINSURER during the term of the Agreement, or during any extension thereof, PRODUCER shall have no further right to direct COMPANY to cede business described in this Agreement. In no event will COMPANY be obligated to cede any premiums processed during a calendar year that is effective PRIOR to the EFFECTIVE DATE of this Agreement.

This Agreement and all accompanying Schedules constitute the entire understanding by the parties hereto with respect of the subject matter hereof and may not be altered, modified, or amended except by mutual agreement in writing by all of the parties.
