## Coverages

### Powertrain Coverage

<b>Engine</b>	All internally lubricated parts; engine block, heads and intake/exhaust manifolds if damaged as a result of a mechanical failure from an internally lubricated part; fuel pump and water pump; thermostat housing.
<b>Transmission Transfer Case</b>	(Manual or automatic) All internally lubricated parts; gear cases and housing if damaged as the result of a mechanical failure from an internally lubricated part; torque converter; vacuum modulator valve.
<b>Drive Axle</b>	(Front and rear) All internally lubricated parts; gear cases and housing if damaged as the result of a mechanical failure from an internally lubricated part; axle shafts and bearings; CV and universal joints, propeller shafts.

### Powertrain Plus Coverage

<b>Air Conditioner</b>	Compressor, compressor clutch and pulley, condenser, evaporator, idler pulley and idler pulley bearing. The following parts are also covered if required in connection with the repair of a covered part listed above: accumulator/receiver dryer, orifice tube, oil and refrigerant, expansion valve, POA valve, and hi-low pressure cut off switch.
<b>Front and Rear Suspension</b>	Upper and lower: control arms, control arm shafts and bushings; upper and lower ball joints; king pins and bushings; stabilizer shaft linkage and bushings, spindle and spindle supports.
<b>Steering</b>	All internally lubricated parts contained within the steering gear box; power cylinder, rack and pinion gear, and power steering pump, plus: pitman arm; idler arm; tie rod ends and drag link; upper and lower steering column shafts and couplings. Steering box and rack and pinion gear housings if damaged as the result of the failure of a covered internal part.
<b>Brakes</b>	Master cylinder; power brake cylinder; vacuum assist booster (excluding hydro boost system), disc brake caliper, wheel cylinders, compensating valve, metal hydraulic lines and fittings.
<b>Electrical</b>	Alternator; voltage regulator; starter motor; starter solenoid and starter drive, front wiper motor, wiper motor relay and delay switch, manually operated switches and wiring harness, window regulator.

Note: Any part not specifically listed above is not covered.
