**1. PARTIES:** This Limited Warranty, which is not an insurance policy, is between the Warrantor, and you, the original owner of the registered vehicle listed herein. The Dealership listed above is not a party to this Limited Warranty and makes no representations or warranties with regard to this agreement.

**2. TERM:** This Limited Warranty shall be in effect for three (3) years from the date of sale of the Theft Code Recovery System on the new or used registered vehicle listed herein. The benefit indicated below will be paid should your vehicle be stolen and **not recovered** within thirty (30) days, as follows:

**3. BENEFIT:** If the Theft Code Recovery System Anti Theft numeric labeling, fails to prevent the theft of the vehicle listed in the registration and said vehicle is stolen within three (3) years from the date of sale of the Theft Code Recovery System, and not recovered within thirty (30) days, **the Warrantor will pay the registered owner \$2,500.00** as a predetermined fixed amount (See State Variations Section). The completion and return of this Limited Warranty application form is a condition of the Limited Warranty Coverage.

**4. CLAIMS PROCEDURE:** In order to qualify for the benefit noted above, the following claim procedure must be followed: If the registered vehicle is stolen, the original registered owner **must notify and submit to the Warrantor (1-800-395-5277) within sixty (60) days of the theft**, information listed below in subsection a, b and c. Failure to do so will cause this Limited Warranty to become null and void.

**IMPORTANT:** This warranty is not valid unless key vehicle body panels or windows are labeled with a numeric #TC I.D. code and entered in the box below

- Copy of police report filed within 30 days from the date of loss.
- Copy of your Theft Code Limited Warranty.
- Proof of automobile purchase in conjunction with, and on the date of, Theft Code attained.

**5. ELIGIBILITY:** a) To be eligible for this Limited Warranty, the Limited Warranty-holder must have comprehensive insurance coverage on the vehicle that is protected by the anti-theft device. This agreement is a product warranty and is not insurance. It is not subject to state insurance laws but is subject to state law concerning warranties. b) This Limited Warranty can only be attained in conjunction with, and on the date of, the purchase of the above referenced vehicle and at an authorized Theft Code dealer.

**6. TRANSFER:** This Limited Warranty may be transferred to a second owner, one time only, provided a \$25.00 transfer fee is made payable to the Warrantor within fifteen (15) days of the sale of the registered vehicle accompanied by copies of the new registered title and the bill of sale.

**7. INCIDENTAL AND CONSEQUENTIAL DAMAGES EXCLUDED:** Customer shall not be entitled to recover from the Warrantor the successors or assigns, any consequential damages, damage to property, damages for loss of use, loss of time, loss of profits, or income, or any other incidental damages. Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

## TERMS AND CONDITIONS

- THE ATTAINMENT OF THIS LIMITED WARRANTY IS NOT REQUIRED EITHER TO PURCHASE OR TO OBTAIN FINANCING FOR A MOTOR VEHICLE. This limited warranty gives you specific legal rights, and you may also have other rights which vary from State to State.

- The Warrantor's performance under this Contract is insured by an insurance policy issued by American Commerce Insurance Company, 3590 Twin Creeks Dr. Columbus, OH 43218-2579, Telephone 1-877-778-3450. If a covered claim is not paid within (60) days after proof of loss has been filed, you may file a claim with American Commerce Insurance Company at the address listed above.
- This Limited Warranty based upon performance of the Theft Code Recovery System and is non-refundable and non-cancelable.
- The Theft Code Recovery System can only be purchased in conjunction with and on the date of purchase of the above-referenced vehicle.
- This agreement is a product warranty and is not insurance. It is not subject to state insurance laws but is subject to state law concerning warranties. To be eligible for this warranty, the warranty holder must have comprehensive insurance coverage on the vehicle that is protected by the antitheft device.
- This Limited Warranty applies only to thefts occurring in the continental United States.

This Agreement is amended to comply with the following state requirements and disclosures:

CALIFORNIA: Benefit: Per CIC § 116.6 (a)(4)(A) The benefits are limited to the difference between the actual cash value of the stolen vehicle and the vehicle's replacement cost, temporary vehicle rental expenses, reimbursement for insurance policy deductible, and registration fees and taxes on a replacement vehicle or a fixed amount for those benefits. To be eligible for this warranty, the warranty holder must have comprehensive insurance coverage on the vehicle that is protected by the antitheft device. The submission of this Limited Warranty form is for product registration and failure to complete and return the form does not diminish Your limited warranty rights.

GEORGIA: Under Terms and Conditions and Claims Procedures sections, any reference to "Failure to do so will VOID this Limited Warranty" is replaced with "Failure to do so will result in Denial of Coverage under this Limited Warranty."

MARYLAND: The obligations of the Warrantor to the Warranty Holder under this Vehicle Protection Product Warranty are guaranteed under a Warranty Reimbursement Insurance Policy. In the event payment due under the terms of the Vehicle Protection Warranty is not provided by the Warrantor within 60 days after proof of loss has been filed by the Warranty Holder in accordance with the terms of the Vehicle Protection Product Warranty, the Warranty Holder may file a claim directly with the insurer that issued the Warranty Reimbursement Insurance Policy.
