## **LIMITED WARRANTY**

### **3 Year KARR Security Vehicle Replacement Program**

In the event that your vehicle is deemed a total loss due to theft, by your insurance company, you will receive the difference between the value of your stolen vehicle and the cost of a replacement vehicle subject to the terms and conditions stated on this form.

The Warrantor's performance under this Contract is insured by American Commerce Insurance Company at 211 Main Street, Webster, MA 01570, ph. 1 (877) 778-3450. If a covered claim is not paid within 60 days after proof of loss has been filed, you may file a claim with American Commerce Insurance Company at the address listed.

**This is a limited warranty subject to the terms and conditions provided herein.**

#### **TERMS AND CONDITIONS**

IMPORTANT NOTICE: FAILURE TO SUBMIT ANY OF THE REQUIRED DOCUMENTS WILL RESULT IN DENIAL OF CLAIM. VEHICLE OWNER MUST NOTIFY KARR SECURITY SYSTEMS OF THE THEFT WITHIN 30 DAYS OF LOSS OR ITS DISCOVERY. ABSOLUTELY NO CLAIM WILL BE PAID IF NOTIFICATION WAS NOT SUBMITTED TO KARR SECURITY SYSTEMS WITHIN THIS TIME FRAME. YOU CAN NOTIFY KARR BY CALLING 1 (800) 395-5277.

1. **DEFINED LIMITED WARRANTY:** Upon presentation of verification of valid loss, as defined below, the Warrantor will pay, on your behalf, the difference between the actual cash value of your vehicle at the time of the theft as determined by your insurance company and the cost of the replacement vehicle. Tax, license or other governmental fees are not covered by this product Limited Warranty. Maximum benefit payable is \$20,000.

IN NO EVENT WILL THE PAYMENT BE MADE DIRECTLY TO THE CUSTOMER.

2. **DEFINED REPLACEMENT VEHICLE:** New Vehicle at time of Purchase: The defined replacement vehicle for a new vehicle is a current model year vehicle of the same make and model, including, but strictly limited to, the identical factory options and accessories affixed to the original vehicle at the time of delivery. Used Vehicle: The defined replacement vehicle for a used vehicle is a similarly aged vehicle of the same make and model, including, but strictly limited to, the identical factory options and accessories, affixed to the original vehicle at the time of delivery. The replacement vehicle will be the same number of years old as your stolen vehicle at the time you originally purchased it.
3. **AGREED (or maximum) REPLACEMENT COST:** In no case shall the replacement cost exceed dealer invoice plus \$1,000.00 for a new car, or NADA wholesale (Trade in) plus \$1,000.00 for a used car.
4. **VALID LOSS:** A loss is valid if the registered vehicle (a) is covered by comprehensive theft insurance, and (b) stolen and not recovered within 30 days, or stolen and recovered but deemed a total loss by the insurance company and (c) the following proof is provided.
5. **PROOF OF VALID LOSS:** A claim is valid only upon receipt by KARR Security Systems of legible copies of all the following: (a) proof that the vehicle was covered by insurance at the time of theft; and (b) proof of payment by the insurance company; and (c) the police report verifying the theft of the registered vehicle; and (d) proof of payment of the KARR Security System.

This Limited Warranty applies only to thefts occurring in the Continental USA and only to the original purchaser of the KARR Security System Upgrade. The original purchaser must be the registered owner at the time of the vehicle theft in order to qualify for any benefit. The replacement vehicle must be purchased within 60 days of the date the comprehensive insurance company makes their settlement. You must contact the Warrantor within the 60 days of insurance settlement. If you are unable to purchase the replacement vehicle before this deadline, the benefit will be denied. In the event the customer wishes to upgrade the replacement vehicle, the Warrantor will only pay the amount the customer would receive if replacing the same model as specified in this Agreement. In the event the customer wishes to purchase a vehicle of lesser value than the defined replacement vehicle, our benefit will be based on the agreed (or maximum) replacement cost of the less expensive vehicle. This Limited Warranty is based upon performance of the KARR Security System and is non-refundable, non-cancelable and non-transferable by the purchaser. A KARR Security System must be permanently installed on the purchaser's vehicle, by an authorized KARR Security Systems technician. This Limited Warranty gives you specific legal rights, and you may also have other rights which vary from State to State.

#### **EXCLUSIONS**

**This KARR Security System is sold with a Limited Warranty, but the Limited Warranty absolutely does not apply to the following:**

1. **Claims as a result of fraud or misrepresentation by or on behalf of the purchaser of the vehicle security system.**
2. **Any service contracts or agreements or any accessories or improvements in the replacement vehicle unless such accessories were permanently affixed to the vehicle by the manufacturer.**
3. **Any claim resulting from war, strike, riot or civil commotion, malicious damage or sabotage during any kinds of public unrest.**

**This Limited Warranty will not be honored if vehicle is seized by any government and Limited Warranty is void in jurisdictions where its terms may be in conflict with State or Federal law. This Limited Warranty applies only to individual acts of theft, and the consequential non-recovery of vehicle, not related to said public unrest. No benefit will be paid under this Limited Warranty if your comprehensive insurance company denies the theft claim.**

## CLAIMS PROCEDURES

1. All claims must be reported to the Administrator through the Claims department within 30 days of the theft at 1 (800) 395-5277.
2. Send legible copies of all of the following required documentation to the Administrator in order to process a claim:
  - a. Copy of Police report that evidences covered vehicle was stolen.
  - b. Copy of the original dealer buyers order with detailed list of factory installed equipment, if any, for the covered vehicle.
  - c. Copy of dealer invoice on suggested replacement vehicle.
  - d. Copy of payment from the personal lines insurer.
  - e. Copy of receipt of purchase and installation of the KARR Security System.
3. **IMPORTANT NOTICE:** Failure to submit any of the above documents will result in denial of any claim.

THE KARR SECURITY SYSTEM ADMINISTRATOR makes the following warranty to YOU as the original purchaser of this system. Should YOUR vehicle in which the KARR ANTI-THEFT SYSTEM is originally installed by an authorized dealer and while the system is operational and activated be stolen and not recovered or if stolen and recovered be deemed a total loss for theft insurance purposes, then subject to the following conditions, YOU will be refunded the comprehensive auto insurance deductible on your existing insurance not to exceed \$2,000.00. This Limited Warranty is effective for thefts occurring within one (1) year from the original date of purchase providing that: (A) the attached registration form has been completed in full and received by the KARR Administrator at the address shown below with a postmark that is within 30 calendar days from the original date of purchase; (B) YOU properly and completely identify the vehicle in which the KARR ANTI-THEFT SYSTEM has been installed; (C) YOUR vehicle is registered within the United States of America or Canada; (D) the theft of YOUR vehicle occurs within the United States of America or Canada; (E) YOU file a complete theft report with the police or other law enforcement agency having jurisdiction at the location of the theft; (F) YOU have comprehensive or theft insurance in force on the vehicle at the time of the theft and YOU have filed a claim for the theft of the vehicle with YOUR insurance carrier; and (G) the theft claim with YOUR insurance carrier is settled and final payment from them has been received.

To obtain repair or replacement within the terms of this Limited Warranty, the product is to be delivered with proof of warranty coverage (e.g. dated bill of sale), specification of defect(s), to an approved warranty station. This Limited Warranty is valid for the original purchaser only and may not be transferred. This Limited Warranty is valid only in the continental United States and Canada.

This Limited Warranty is in lieu of all other express warranties or liabilities. ANY IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY, SHALL BE LIMITED TO THE DURATION OF THIS WRITTEN LIMITED WARRANTY.
